vLex Canada and U.S.

- Canadian and American caselaw and commentary. Canadian content is provided by the former Maritime Law Book's national reporting series, including its extensive indexing system, with new caselaw continuing to be added and edited. U.S. content includes federal and state case law going back to at least the 1930s; legislation includes archived versions of the U.S. Code since 2000; a negative citator system provided in partnership with Casemaker.

PRINT PUBLICATIONS

We also purchase print materials, which may be used in the library or borrowed for use in your office.

- Leading looseleaf titles in the area of competency, conflicts, employment law, class actions, administrative law, constitutional law, criminal law
- Leading texts on evidence, contractual interpretation, construction of statutes, limitations of actions, trusts
