

### Create an account in Lexbox


1. Set up a free-standing <u>account</u> for Lexbox by filling in the required information.












# Setting up the Alerts


1. From the search screen select Set up alert feed




#### 2. Go through the following steps




- Name: Name the alert whatever you like. I will name this alert "QB Family"
- Folder: Make and select a folder





• **Tracking**: A description of what your alert is being created for.

• **Notifications**: You have an option of how many times you will be notified of your alerts. Choose what will suit your needs best.



You can now see your alert in your Lexbox.
